Under the visionary leadership of Walter Ambu, Entando transformed over the years, evolving from a service company creating web portals for businesses and public administrations into a product company by developing an application composition platform.

2020

In 2020, leveraging the experience gained, Ambu launched an innovative idea: a platform to modernize companies' traditional applications through the concept of "Composability." This approach offered greater agility, faster development, reduced maintenance costs, and superior scalability, enabling companies to assemble applications using pre-existing components in a flexible and scalable way.

2022

In 2022, the technology landscape saw a significant change when Gartner, a multinational leader in strategic consulting, market research, and analysis in the field of information technology, identified a new category of software products called "Application Composition Platform." In this context, Entando evolved its offering, becoming a vendor of Application Composition Platforms. This transformation allowed Entando to be recognized as one of the first Sample Vendors globally in this category and the first in the open-source field.

2023

In 2023, Entando received further recognition. In its reports, Gartner highlighted Entando's key role in facilitating the adoption of composable and cloud-native architectures and methodologies. The Entando platform accelerates application modernization, enabling the rapid integration of business components and meeting customers' evolving expectations for faster application delivery.

2024

In 2024, Entando was included in several Gartner reports, including the "Emerging Tech Impact Radar," as a relevant vendor in cloud-native technologies. In February, it launched version 7.3 of its platform, and in June, it signed a strategic agreement with the Slovak government to promote its adoption in Eastern Europe.

Today, Entando is not only a leader in the Application Composition Platforms sector, but also an example of how innovation and strategic vision can transform a company, enabling it to adapt and thrive in a constantly evolving market. With a solid foundation of recognition and a promising future, Entando continues to drive innovation in the field of composable platforms, demonstrating that with determination and vision, it is possible to redefine the standards of the technology sector.

The Context

A broad catalog of reusable components, tailor-made within the organization and covering different functional areas, helps bridge the gap between technical and business needs, ensuring applications that meet both strategic objectives and operational requirements.

The integration of new components or the creation of customized solutions fosters a culture of continuous innovation. This approach enables the development of modular business

capabilities, the curation and updating of components in use, and the dynamic management of the application lifecycle. The result is a reduction in development and maintenance costs, along with an increase in speed and efficiency in development processes

Thanks to its modular and scalable ecosystem, enterprises can enhance organizational agility, lower development costs, and respond more swiftly to market changes.



Solid roots for a sustainable future: our governance

Entando's corporate governance system is built on strong ethical principles and aligned with best practices at both national and international level, with the goal of ensuring transparent management, clear communication with the market, and protection of key social interests.

In 2023, Entando adopted the Organization, Management, and Control Model pursuant to Italian Legislative Decree 231/2001, designed to ensure regulatory compliance and prevent the commission of corporate crimes. This model applies to all employees, collaborators, and business partners, with the aim of ensuring that operations are carried out lawfully and ethically.

The model includes, among other aspects, the monitoring of specific risk areas, such as cybercrimes and unlawful data processing, which are essential to safeguarding sensitive information and protecting corporate data. It also addresses crimes against public administration, ensuring that every interaction with public entities is conducted with full transparency and in compliance with regulations.

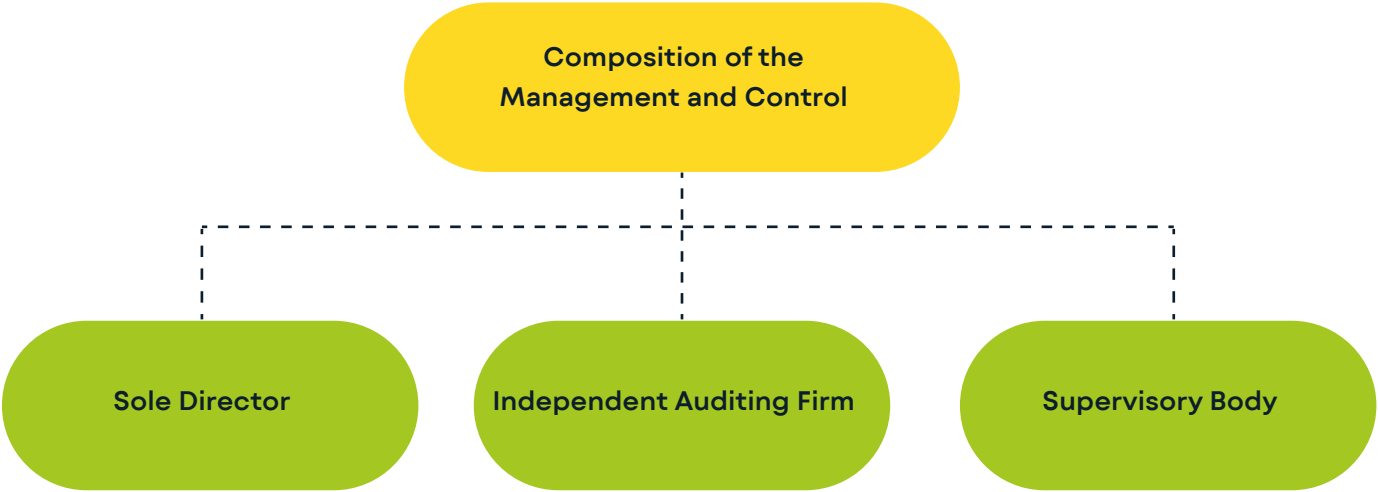
To further strengthen the control system, Entando has implemented a rigorous whistleblowing procedure that enables employees, collaborators, suppliers, and any other party interacting with the company to report potential misconduct or violations of the model safely and anonymously. The reporting channel, available on the dedicated “Model 231” section of the company website, guarantees maximum confidentiality and protection against retaliation. Use of this channel is governed by the whistleblowing policy, also available online, which sets out the rules and principles for proper handling of reports.

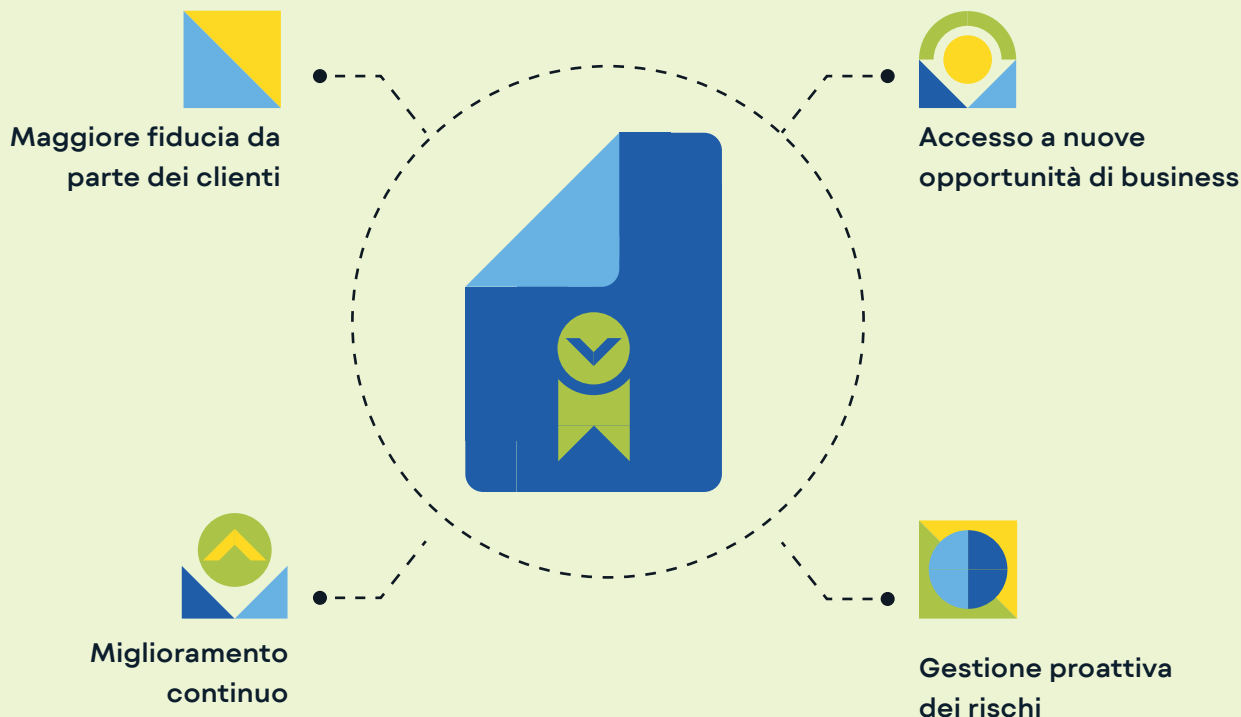
The Code of Ethics is a cornerstone of the corporate governance system and an integral part of Model 231. It defines the standards of conduct that guide all company activities. Based on integrity, transparency, and accountability, the Code applies to employees, collaborators, suppliers, and stakeholders, ensuring that every action is carried out in compliance with

regulations and the highest ethical standards. Beyond regulating conflict-of-interest situations, the document promotes fairness in both internal and external relations, guaranteeing impartiality in business decisions. It also fosters a culture of legality and compliance, reinforced by control mechanisms such as the whistleblowing procedure, which allows irregularities to be reported securely and confidentially. The application of the Code strengthens stakeholder trust and supports sustainable growth in line with the company’s values and strategic goals.

Entando has adopted a traditional governance model, with a Sole Director as the management body and an external audit firm responsible for accounting oversight. The Sole Director also holds responsibility for the company’s sustainability strategy, confirming Entando’s commitment to responsible and transparent growth.

The implementation of this governance system not only ensures compliance with regulations, but also reflects Entando’s dedication to building a corporate environment rooted in integrity, accountability, and stakeholder protection.

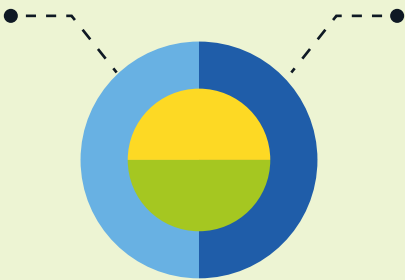

Creating Value Together: Our Supplier Network

In 2024, Entando collaborated with 167 suppliers, strengthening a strategic supply network built on quality, reliability, and innovation. Most of our suppliers are based in Italy, while 22% operate in international markets—reflecting a balance between local presence and global openness.

Our supplier selection is always made with great care, focusing on those who meet high standards of quality, transparency, and reliability. To reinforce this commitment and ensure a rigorous selection process, we chose to obtain ISO 9001 certification. This certification is a value-added element, demonstrating our attention to supplier selection and ensuring we work only with partners who share our principles of excellence and continuous improvement.

Among our suppliers, 17% specialize in internet services, highlighting the importance of digital infrastructure within our ecosystem. The remaining 83% consists of providers of other services, carefully selected to meet the quality and operational standards required by our organization.

This approach allows us to build a resilient and sustainable supply chain that supports our growth and innovation, ensuring advanced technological solutions capable of addressing the challenges of the global market.

Sustainability

The 2024 Sustainability Report includes Environmental, Social, and Governance (ESG) data covering the entire reporting period from January 1 to December 31, 2024.

Transparency and Innovation: Our Approach to Sustainability 2024

Throughout 2024, we launched a comprehensive initiative to evaluate and analyze the current and potential impacts of our business activities and relationships on the environment and people's well-being. This process included an assessment of both positive and negative aspects, aligned with Entando's commitment to sustainability. The objective is to ensure a responsible and informed management of our operations, with a constant focus on improving business performance and our overall impact on the community and the environment.

The materiality analysis was divided into three main phases:

Identification:

in line with Entando's strategic priorities, all potential material topics were identified through a detailed review of internal documentation, an analysis of major socio-environmental trends in the industry, and a benchmarking study. The latter involved evaluating a sample of comparable and competing companies operating in Italy, with a focus on relevant ESG aspects, based on publicly available sources.

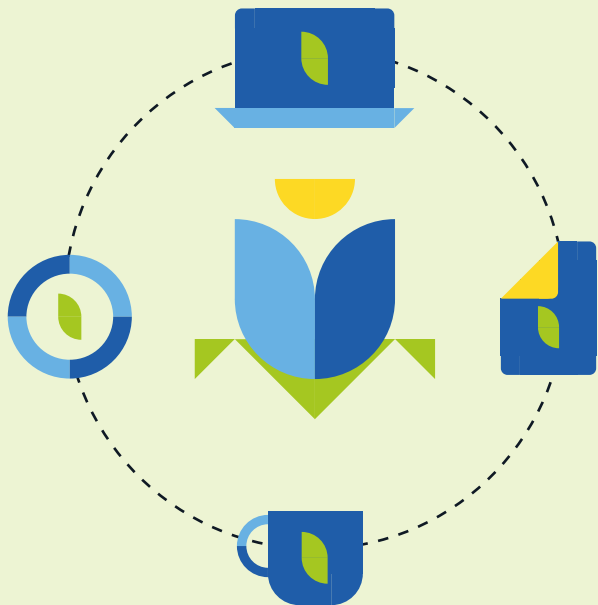
Survey:

a questionnaire was administered to a selected group of stakeholders to explore key ESG priorities. This step allowed for the evaluation of potential material topics and their associated indicators.

Reprocessing and Analysis:

the results were analyzed and reprocessed to identify the main material trends.

The material topics identified relate to the areas of Environment, Social, and Governance. Within these areas, the most relevant themes for our stakeholders were selected.



Environmental Sustainability: Actions and Results

Throughout 2024, Entando continued its commitment to environmental sustainability, strengthening and expanding its efforts to reduce the environmental impact of its operations. The company further integrated environmental protection and energy efficiency principles into its business model, with the aim of optimizing resource consumption, minimizing waste, and preventing pollution. Environmentally friendly policies, procedures, and practices have become core pillars of the company's philosophy.

Over the course of the year, Entando implemented new initiatives to reduce plastic use, adopting innovative strategies to monitor energy consumption and waste production. The company continued to promote the correct collection and disposal of waste generated at its headquarters, thus contributing to the responsible management of materials.

Entando also reinforced its commitment to selecting equipment, work tools, and consumer goods with a low environmental impact, favoring solutions that respect the environment without compromising operational efficiency. This approach has not only strengthened Entando's reputation as a socially responsible company but has also produced tangible benefits in terms of reducing the overall environmental footprint of its activities.

Entando's daily commitment to environmental sustainability reflects its awareness of the importance of adopting responsible business practices to help preserve the environment for future generations.

A Sustainability Journey: Strong Roots, Forward Vision

For Entando, sustainability is not an abstract concept but a guiding principle that shapes every strategic and operational decision. Reducing environmental impact is a responsibility the company has consciously and resolutely embraced, turning it into concrete and measurable actions. The progress achieved to date reflects not only the consolidation of choices made in previous years but also the foundation for future developments. Reviewing these results highlights the consistency of a path that, year after year, continues to grow stronger and broader, integrating new solutions to ensure increasingly sustainable operations.



Clean Energy, Reduced Consumption: Entando's Sustainable Future

Energy management has always been a key pillar of Entando's environmental strategy. In 2024, as in previous years, the company ensured that 100% of the energy it used came from renewable sources, further reinforcing its low-impact operating model. Energy consumption in 2024 decreased by 10% compared to 2023, despite the gradual return of some employees to the office. This result is particularly significant, as overall consumption was about the same as in 2022—a year in which most staff were working remotely.



Reducing Waste, Increasing Efficiency: Our Commitment to the Planet

Responsible waste management is a core component of Entando's environmental policies. Waste sorting, already well established within company practices, has been further optimized to enhance resource efficiency and reduce the environmental impact associated with production and operational waste.

This is complemented by a focus on the management of electronic equipment. The implementation of recycling and reuse programs for obsolete devices has helped reduce the accumulation of technological waste and extend the lifecycle of IT resources, in line with the principles of the circular economy. Devices that are no longer functional are either traded in or sold, while those still fit for use are reintegrated into the operational cycle, thereby reducing the need for new production and, consequently, the environmental impact of the technology sector.

In pursuit of increasingly sustainable operations, since 2023 Entando has strengthened its environmental efforts by adopting procurement practices that prioritize reusable and recyclable goods for its headquarters, while progressively phasing out single-use devices. This policy has led to a significant reduction in plastic waste, promoting a corporate culture rooted in environmental responsibility and conscious resource usage.



Yesterday, Today, and Beyond: Open Source Supporting the Environment

Since its inception, the Entando platform has been developed as open source, laying the foundation for a technology model built on flexibility, efficiency, and sustainability. The adoption of open source solutions remains a key element of the company's environmental strategy, helping reduce reliance on proprietary, energy-intensive software and supporting the optimization of digital resources. This approach improves consumption efficiency, extends the lifecycle of IT infrastructure, and reduces the need for frequent hardware upgrades, thereby limiting electronic waste production.

Moreover, the use of open technologies ensures greater interoperability and scalability, enabling a more sustainable transition for the company's digital ecosystem.

The results achieved so far are not an endpoint, but a step in a process of continuous improvement. Every initiative implemented and every choice made reflects a broader commitment to operating in an increasingly sustainable and responsible way.



Minimal Impact, Maximum Value: Our Sustainability Journey

Entando is committed to integrating ESG principles into its business processes by adopting a strategic and measurable approach to sustainability. In this context, we conducted a detailed assessment of the environmental impact of one of our corporate events, with the aim of quantifying, reducing, and offsetting the CO₂ emissions generated.

Thanks to the collaboration with a certified B Corp consultancy, we were able to calculate the carbon footprint of an Entando event, which amounted to a total of 2,541.56 kg of CO₂ equivalent. The main sources of emissions were identified as meals served, participant travel, distributed giveaways, and accommodations.

Based on these findings, Entando implemented targeted measures to reduce the event's environmental impact. In particular, selecting a conveniently located venue helped minimize travel-related emissions. The event was also organized according to eco-efficient principles, adopting a plastic-free and paperless format that eliminated the use of plastic and paper-based giveaways. Additionally, awareness initiatives were launched to encourage participants to adopt sustainable practices.

Acknowledging that not all emissions can be eliminated, Entando chose to offset the remaining carbon footprint by purchasing Verified Carbon Standard (VCS) certified carbon credits.



Innovation and Sustainability: Green Giveaways for a Better Future

In 2024, Entando further strengthened its commitment to environmental sustainability by introducing giveaways made exclusively from recycled materials. This initiative is part of a broader corporate strategy aimed at reducing the consumption of primary resources and promoting a responsible and efficient production model.

As part of its events and corporate activities, Entando carefully selected recycled-paper notebooks and inkless pens, ensuring both quality and functionality. The notebooks, made from certified recycled paper, help reduce the use of virgin cellulose, while the inkless pens, offer an innovative and sustainable alternative in the stationery sector.

This initiative supports a wider transition toward a responsible supply chain, where the selection of materials and suppliers is based on environmental sustainability criteria. It also raises awareness among employees and stakeholders about the importance of low-impact solutions, encouraging the adoption of sustainable practices in daily operations.

Through this responsible sourcing policy, Entando continues to advance its environmental sustainability efforts, in alignment with ESG goals and its commitment to embedding sustainability into every aspect of its operations.

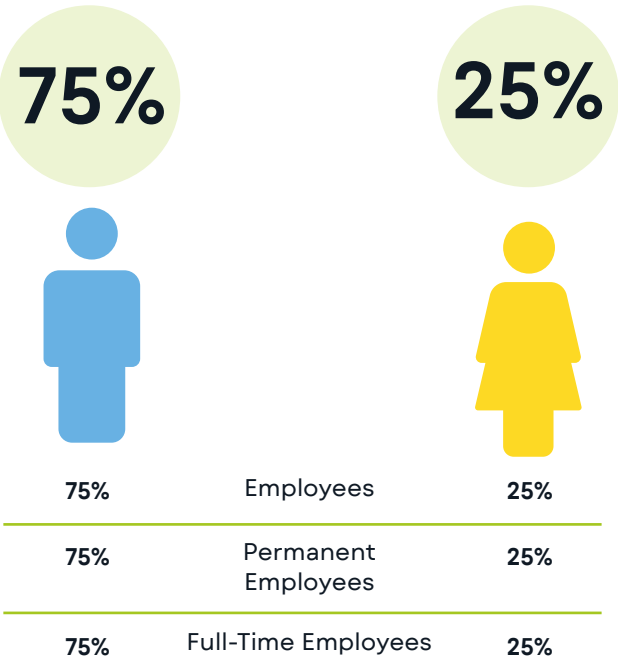

Meal vouchers are a company benefit that provides employees with practical and financial support in managing their daily food expenses. Entando offers meal vouchers that can be used at restaurants, cafés, pizzerias, supermarkets, agritourisms, and fish farms, ensuring a wide range of options to meet diverse needs.

The main advantages of this benefit include:

- Usable for grocery shopping:** in addition to dining, meal vouchers can be used to purchase food items at participating supermarkets, offering practical support for household groceries.
- Nationwide and digital availability:** vouchers can be used throughout the national territory and are available in electronic format, simplifying transactions and providing greater ease of use.
- Tax exemption:** meal vouchers benefit from favorable tax treatment, being exempt from social security contributions and income tax up to the limits established by current regulations.
- Better lunch break management:** they allow employees to access a wide range of options without having to pay in advance, reducing personal expenses and making lunch breaks easier to manage—whether in the office or while working remotely.
- Cumulative use:** depending on the merchant’s policy, vouchers can be combined to cover expenses exceeding the value of a single ticket, increasing their flexibility of use.

This initiative is part of Entando’s ongoing commitment to providing its employees with practical tools to better manage daily expenses, offering a tangible and accessible benefit.

Smart Working: Flexibility and Autonomy

Entando has adopted smart working as an organizational model to provide employees with greater autonomy in managing their work. This approach, based on trust and responsibility, allows team members to organize their tasks with increased flexibility, choosing where and when to work according to their individual needs and company objectives.

Agile work not only supports a better work-life balance but also reduces the environmental impact associated with commuting and contributes to greater operational efficiency. The opportunity to work remotely therefore represents an added value for both employees and the company, fostering a results-oriented and well-being-focused culture.

Health and Safety: Prevention, Well-being, and Responsibility

At Entando, employee safety and well-being are top priorities. In accordance with Legislative Decree 81/2008 on health and safety in the workplace, we rigorously comply with current regulations, with a particular focus on risk information and prevention.

Each employee, upon hiring, receives and signs a workplace safety notice, which includes proper conduct guidelines to be followed also while working remotely. Additionally, employees are required to undergo medical examinations to assess their fitness for work, as mandated by law and the applicable National Collective Labour Agreement (CCNL). Failure to comply with medical assessments results in suspension from work without pay, following a written notice. The outcomes of these examinations are treated confidentially and are not shared with the company, except for the fitness-for-duty confirmation issued by the occupational physician.

Occupational health is monitored by qualified professionals, including the company physician, in collaboration with Human Resources. The health protocol includes medical check-ups every five years for employees under the age of 50 and every two years for those over 50 or with specific medical requirements. Employees may also request assessments to verify fitness for specific duties. All medical data is handled in compliance with privacy regulations and shared in aggregated form with the relevant stakeholders.

Since 2018, Entando employees and managers have benefited from EBM Salute, the supplementary healthcare fund provided by the Metalworkers' National Collective Labour Agreement dated July 3, 2017. Established in 2018 by Unionmeccanica Confapi, Fim-Cisl, Fiom-Cgil, and Uilm-Uil, EBM Salute offers supplementary health services to the National Health Service for employees of participating companies, operating on a non-profit basis.

Entando is committed to promoting a safe and healthy work environment that also supports the physical and mental well-being of its employees. Through internal communication tools and regular meetings organized by Human Resources, we foster open dialogue, enabling team members to express their needs and feel fully integrated into the company.
